### WARNING

- Allow students to review questions before pausing the test. If a test is paused and resumed after 20 minutes, the student cannot review previously flagged or answered questions.
- (For ELA and Math ISAT) Allow students to complete the current segment before moving to the next segment. If a student moves to the next segment, the student cannot review questions in the previous segment.
- Immediately discontinue testing by pausing the test when:
  - encountering unexpected technical difficulties. Report any audio, video, or platform issues to the AIR helpdesk at 1-844-560-7365 or [IDHelpDesk@air.org](mailto:IDHelpDesk@air.org).
  - student apathy or known/unexpected medical/behavioral conditions are observed. Reschedule when appropriate.
- Submit the test only when the student is finished. The test cannot be reverted to the un-submitted status.

### The Week in Review

The majority of calls I received this week centered on types of supports and accommodations and how to code them. As I have talked through questions I always remind people to **ask the student** about support and accommodations choices. Ask them how they feel about a certain type of support and show them what it looks like in a practice test or sample item. You can apply accessibility choices to sample items on this site:

### Important Dates

- **March 19, 2018:** The ISAT ELA/literacy and Math test window opens on this date. Please remind teachers and proctors that all assessments available at this time are secure tests and should not be confused with interim assessments.
- **May 4, 2018:** Testing should be completed by this time. May 7-18, 2018 are make-up days for students who missed testing.

### Possible "Walk Out" dates:

Information and guidance on nationally promoted student led walk out efforts that may involve local rallies was provided to superintendents on March 2, 2018. It is recommended that you do not schedule testing on this date: April 20, 2018.

## ALTERNATE ASSESSMENT

### Attention visitors to the Alternate Universe... Speed bumps ahead...

The **ISAT-Alt Science** testing deadline is looming! The window closes on March 31, 2018 and many districts have spring break during one of the next two weeks. This leaves a lot of teachers with only one week left to upload and submit ISAT-Alt Science Portfolios in IPASS. **GACK!** IPASS data show that of the 814 students currently in the application, only 10 students are left without teacher assignments, 259 portfolios have not been started, 146 are in progress, and 366. We are moving in the right direction to get portfolio completed, but still have a lot to do to cross the "IPASS finish line." Keep up the good work supporting your teachers.

The **Directions for Test Administration (DTAs) for ISAT-Alt ELA/Literacy and Math** are now available in TIDE. You may download these resources by selecting the Inbox feature located in the top blue banner. At this time, only School Coordinators (SCs), Teachers (TEs), and Test Administrators (TAs) will have access to download these resources. **It is important that teachers who will administer the ISAT-Alt become familiar with the DTAs for the grades and contents they will be administering to ensure a smooth testing experience for themselves and their students.** Please keep in mind that DTAs are secure test materials and should be handled with the level of security accorded to any other ISAT secure test materials.

The ISAT-Alt ELA/Literacy and Math testing window opens on Monday, March 26, 2018. You will notice this is one week later than the regular assessment testing window. Teachers should still have plenty of time to complete testing with all their students. Even though the testing window does not open for a week, the **Learner Characteristics Inventory (LCI)** is open in the Data Entry Interface (DEI). As of March 9, 2018, LCIs had been completed for only 24 out of the 1389 students coded for the ISAT-Alt. **Teachers must complete the LCI before a student can take an alternate assessment.** The good news is that teachers only need to complete the LCI once.

## ACCUPLACER

The testing windows are open! The testing windows are:

- ACCUPLACER Placement: **February 5-April 30, 2018**
- ACCUPLACER Diagnostic: **February 5-May 5, 2018**

Here are some helpful hints for test administration:

- Before administration, please verify **each** testing computer meets the system requirements. To do so, please visit the [ACCUPLACER login page](#). At the bottom, right hand corner of the screen, click "Verify System." This will prompt a window to open informing you if the computer meets specifications required to administer the ACCUPLACER assessments. If the computer fails to meet specifications, ACCUPLACER will advise what upgrades are needed.

## SAT

**Idaho SAT School Day is around the corner: April 10, 2018**

### Materials Shipment Updates:

- Pre ID Labels: Mid-March. These should be affixed to student response sheets in preparation of test day and/or a pre-test session with students.
- Test Day Materials: First week in April, unless school is on Spring Break.

We encourage a pre-test session with students to assist them in understanding the potentials of taking the SAT, how to prepare, what to expect, and can be a positive chance to share resources on choices after high school. Even if students are undecided on college choice, please encourage the four free score sends.

### Makeup test date: April 24, 2018

College Board will be sending a makeup test day form to all test supervisors immediately after the SAT Day. Please respond to this required form ASAP even if you do not have makeup testers. The form also serves as the mechanism for reporting test irregularities and

improprieties. The College Board will review and alert schools as to whether these students can participate in the makeup exam.

## **ACCESS 2.0**

- **ACCESS 2.0 Score Reports will be available:** May 18, 2018
- **Data Validation:** School or district level ACCESS points of contact are to complete data validation April 2-April 6, 2018.
  - This important pre-reporting task will allow you to correct any student demographics and merge certain domains that have been scored but may not reflect a composite score due to the need to merge. It is vital to ensure EDU IDs are accurate and complete.
