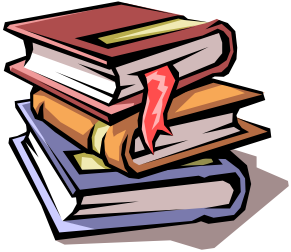

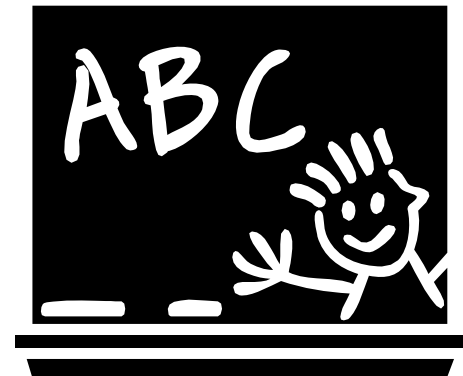

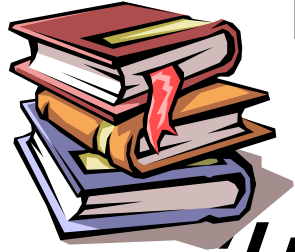
Steps - Experience Factor

"In determining the experience factor, the actual years of teaching or administrative service in a public school or in an accredited private or parochial school shall be credited."





Lanes - Experience Factor

I.C. 33-1004A

In determining the experience factor, the actual years of teaching or administrative service in a public school or in an accredited private or parochial school, or beginning in the 2005-2006 school year and thereafter in an accredited college or university shall be credited."

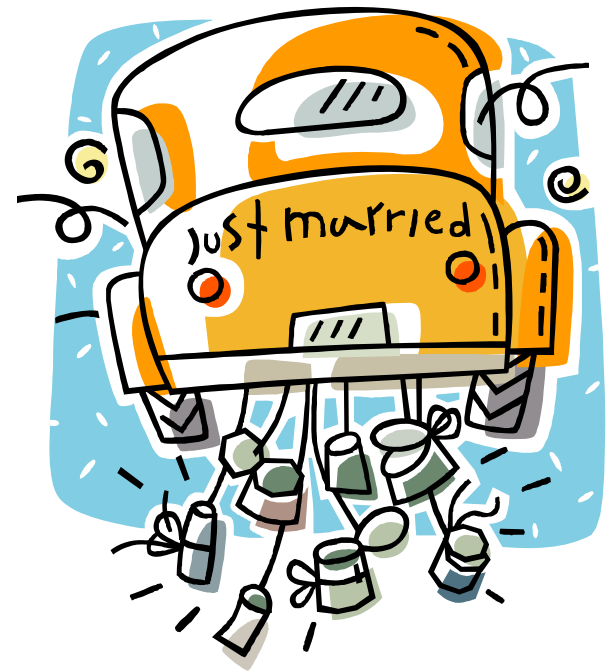

- Think of it like your 1st year marriage, you had to survive 365+ days before celebrating your 1st anniversary

 - Because the school being accredited should be an indication that the institution employs credentialed teachers and administrators.

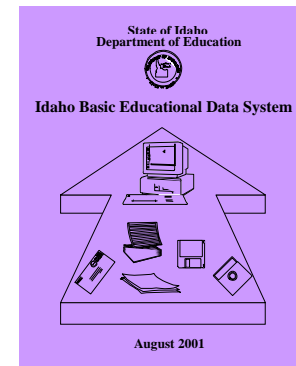

- Not general pre-K or headstart

Reporting

Idaho Basic Education Data System (I.C. 33-1004D)

“For each employee of the school district, a report shall be made in a format prescribed by the state superintendent of public instruction,…” See IBEDS Manual for additional assistance in placing certified staff/positions on the experience and education multiplier table.

Other Guidelines Included in the IBEDS Manual

Experience **prior** to becoming certified or obtaining special approval to teach by the Board of Education should **not** be included (i.e. student teaching, internships/curriculums where the individual is not a certified employee of a K-12 institution).

“Temporary Permits” issued by a state Board of Education - **experience yes**

How do I Report Experience?

Other Guidelines Included in the IBEDS Manual

Employment in **foreign countries** should be reported **according to Idaho standards**.

Experience in other countries may be included with an employees experience for IBEDS purposes provided the instruction is **equivalent to K-12 instruction in this country**.

Districts will need to assess each situation on a **case-by-case basis** to determine if the experience is equivalent to an accredited K-12 experience in Idaho.

How do I Report Experience?

Other Guidelines Included in the IBEDS Manual

Employment in **foreign countries** should be reported **according to Idaho standards**. Experience in other countries may be included with an employees experience for IBEDS purposes provided the instruction is **equivalent to K-12 instruction in this country**. Districts will need to assess each situation on a **case-by-case basis** to determine if the experience is equivalent to an accredited K-12 experience in Idaho.

Example: John taught six-year old students at a "public" institution in London for 3 years. The school is the equivalent of an accredited public Grade 1 institution in Idaho. A "public" school in England is the equivalent of a non-public school in Idaho. John has no other work experience. John would be reported with 3 years non-public experience.

A certified employee must teach 50% or more of any given year to be given credit for that year.

How do I Report Experience?

Other Guidelines Included in the IBEDS Manual

A certified employee must teach 50% or more of any given year to be given credit for that year. See the following examples.

Example:

If Mary teaches 3 periods of a 7-period day for the entire school year.

For IBEDS purposes, her experience is **zero** for this year ~ she did not teach 50% or more of the total hours in the school year (**$3/7 = 43\%$**).

How do I Report Experience?

Other Guidelines Included in the IBEDS Manual

A certified employee must teach 50% or more of any given year to be given credit for that year. See the following examples.

Example:

If Harry teaches 90 days of a 180-day (full-year) contract.

Harry's experience for this year is one (1) year ~ he completed 50% of the school year.

How do I Report Experience?

Other Guidelines Included in the IBEDS Manual

Example:

*But if Harry contracts to teach **90 days** of a **180-day** (full-year) contract.*

But takes 5 of those days to go hunting

*Harry's experience for this year is **Zero000** ~ he failed to complete 50% of the school year.*

How do I Report Experience?

Other Guidelines Included in the IBEDS Manual

Next Example:

*Joan teaches 3 periods of a 7-period day for the **2006-2007** school year.*

*And taught full-time four months during the **2007-2008** school year.*

*For IBEDS purposes, her experience is **zero***

- 1) she did not teach 50% or more in either school year, and*
- 2) partial years cannot be added together to accumulate work*

How do I Report Experience?

Other Guidelines Included in the IBEDS Manual

Beginning with the 2006-2007 school year completed experience with an accredited college or university may be recognized for those hired in a certificated position (instructional or administrative) where the hire date is **after June 30, 2005**. Employment in accredited colleges or universities should be according to Idaho standards and may be included with an employees experience for IBEDS purposes provided the instruction is equivalent to K-12 instruction environment.

Districts will need to assess each situation on a case-by-case basis to determine if the experience is equivalent to an accredited K-12 experience in Idaho.

How do I Report Experience?

Other Guidelines Included in the IBEDS Manual

Beginning with the 2006-2007 school year completed experience with an accredited college or university may be recognized for those hired in a certificated position (instructional or administrative) where the hire date is **after June 30, 2005**. Employment in accredited colleges or universities should be according to Idaho standards and may be included with an employees experience for IBEDS purposes provided the instruction is equivalent to K-12 instruction environment

Example:

*Tom taught English at Boise State University for 5 years, for which his **students received college transcript credit** for his classes. He taught over 20 hours per week for nine (9) months each year. On **August 15, 2005** he begins teaching for an Idaho school District/charter as a full-time teacher. For IBEDS purposes, his **completed work experience is 5 years** because 1) he taught 50% or more in each school year in an accredited university, and 2) his hire date was after June 30, 2005..*

Other Guidelines Included in the IBEDS Manual

Example:

*Tom teaches English at BSU for 5 years,
His **students received college transcript credit**
for his classes.*

*He taught over 20 hours per week for nine (9)
months each year.*

***August 15, 2005** he begins teaching for an
Idaho school District/charter as a full-
time teacher.*

For IBEDS purposes,

*his **completed experience is 5 years***

- 1) he taught 50% or more in each school year*
- 2) BSU is an accredited university, and*
- 2) his hire date was after June 30, 2005..*

And Another Example:

Molly taught Biology at ISU for 15 years,

Her students received credit for these classes.

She taught over 20 hours per week for nine (9) months each year.

However, Molly began working full-time as a teacher in a Idaho school District in SY 2004-2005

For IBEDS purposes, Molly cannot count any of her experience at Idaho State because her hire date was prior to July 1, 2005.

Okay ~ here's the extreme, but it can happen

Paul has been a full-time employee in the Registration Office at the U of I for 10 years.

He's has accepted a teaching position with an Idaho public school District/charter For the 2008-2009 school year.

For IBEDS purposes, his work experience is zero ~

Why ~ experience in the business office was not the equivalent of teaching or administrative experience in a K-12 instructional or administrative environment.

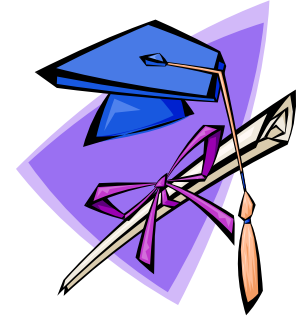

Education Factor

I.C. 33-1004A

SDE receives transcript when Certificates are renewed - usually every five (5) years

*"In determining the education factor, only credits earned **after** initial certification, based upon a transcript on file with the teacher certification office of the state department of education, earned at an institution of higher education, or a state board accrediting agency, are allowed."*

For IBEDS Purposes ~

A transcript should be on file with the district/Charter if they are reported on the IBEDS Ed History Record.
