Test Ordering Site Updates and Winter PSAT/NMSQT

Dear Educator,

We're following up on our July 30 email to alert you that the test ordering site can now be used to place orders for multiple Preliminary SAT/National Merit Scholarship Qualifying Test (PSAT/NMSQT®) test dates. In addition, College Board will also be offering the PSAT/NMSQT this winter.

Schools Can Now:

- **Place Orders for Multiple PSAT/NMSQT Test Dates:** For fall 2020, you can test students across multiple PSAT/NMSQT administration dates. This flexibility already existed for PSAT™ 8/9 and SAT® School Day.
- **See Revised Test Dates:** The PSAT/NMSQT alternate and SAT School Day makeup test dates have been adjusted on our test ordering site to provide testing options on different days of the week (see the chart below). Please update your calendars or update your orders accordingly.

- **PSAT/NMSQT:** If you previously placed an order for the original alternate date (Wednesday, October 28), your order will be automatically shifted to Thursday, October 29. You're required to administer the PSAT/NMSQT alternate test on the revised date of October 29.
- **SAT School Day:** If you'll need to use the makeup as another opportunity to test your students, you'll be able to order for October 27 following the primary administrations. Please plan to place your makeup order immediately following your primary test date (the deadlines are below).

Please refer to your state department of education for specifics regarding state-sponsored test dates.

Winter Administration	We understand many schools are utilizing virtual instruction options and that plans continue to evolve this fall. For schools that are unable to administer the PSAT/NMSQT in October, College Board will also be offering the PSAT/NMSQT this winter, which will be used for programs administered by National Merit Scholarship Corporation. You'll receive another email with more details by the end of the month.

Unused Test Fees Are Waived for Fall 2020: As a reminder, schools won't be charged test fees if they're unable to administer SAT School Day, PSAT/NMSQT, and PSAT 8/9 this fall. We understand the decision to test may not be made until closer to the administration dates; please adjust your test book volumes the best you can by the ordering deadlines.


