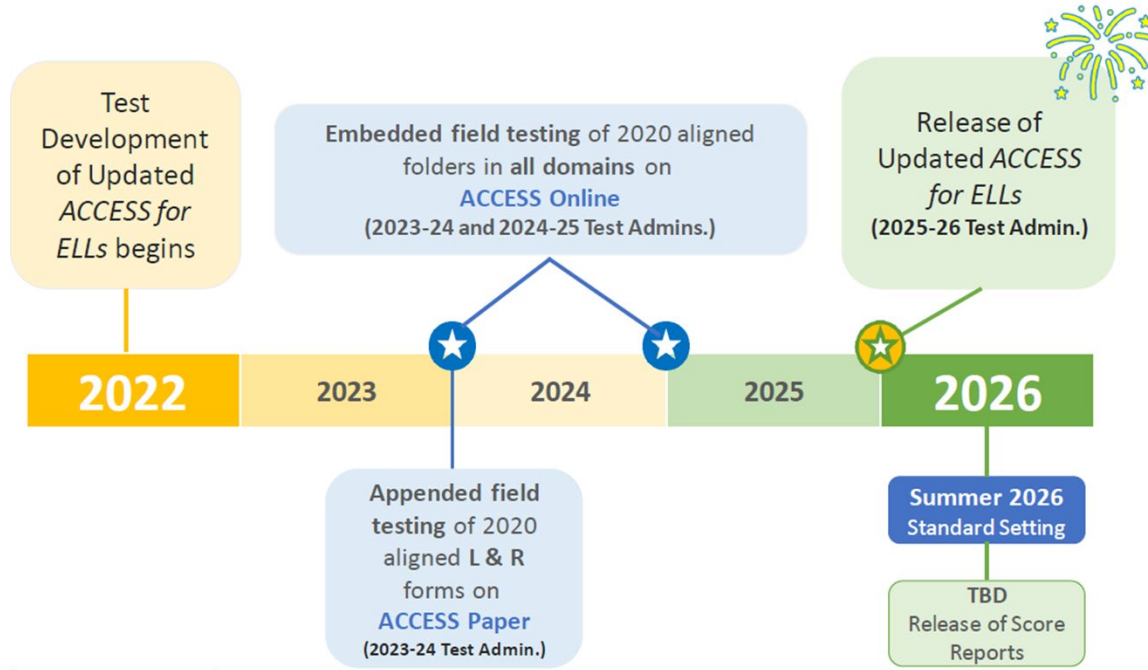

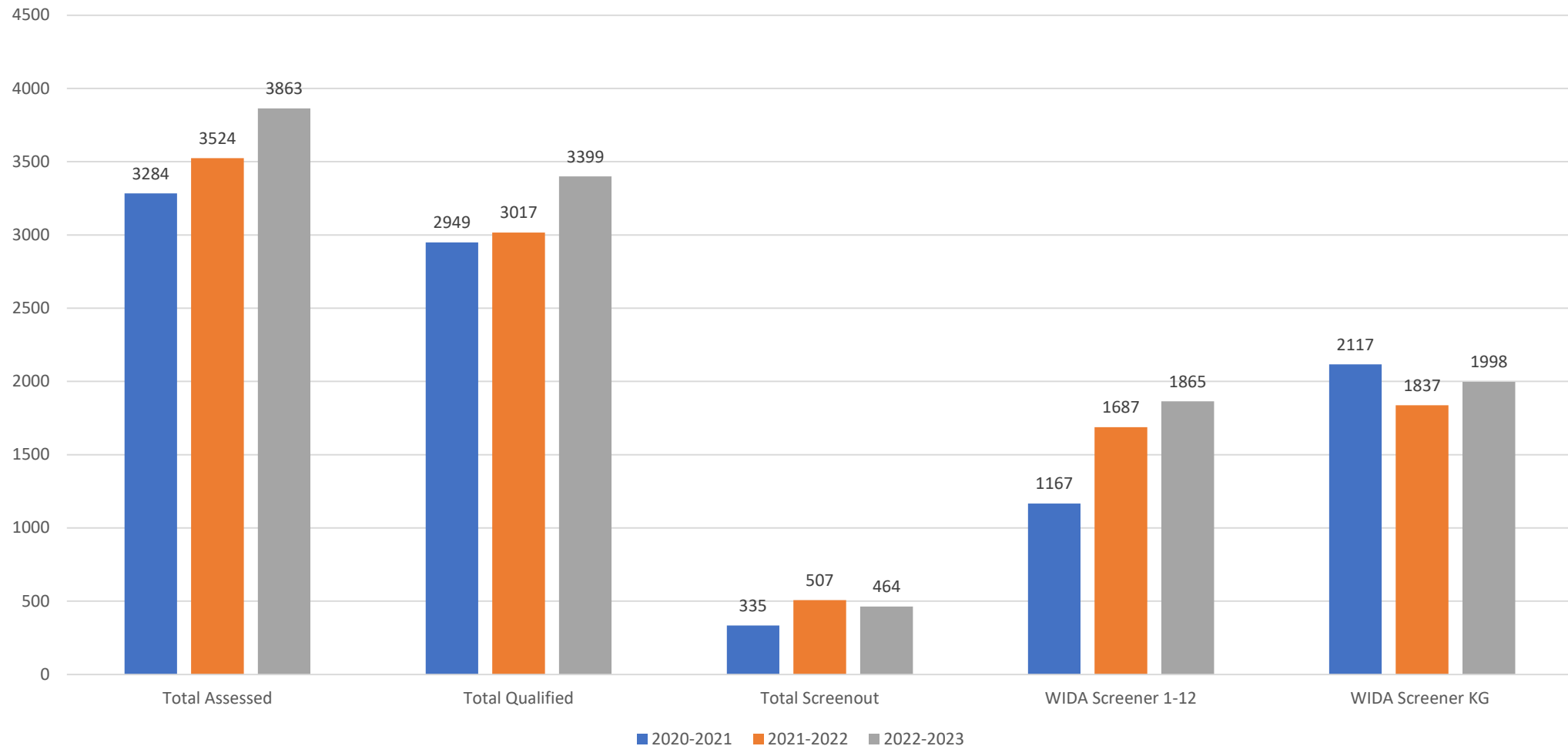

WIDA Screener & EL Identification 2020-2023

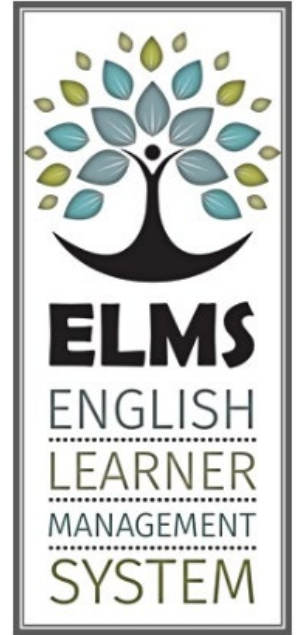




# English Learner Management System 2023-2024 Enhancement

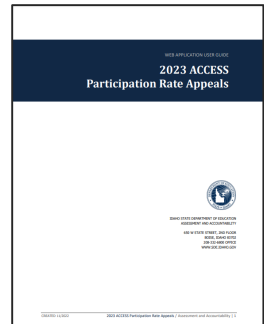

# ACCESS for ELLs Participation Rate Appeals Appeals Window



## ACCESS Participation Rate Appeals Window May 22, 2023 – June 2, 2023 5:00PM MT

- The ACCESS Participation Rate Appeals process provides districts the opportunity to adjust the district's English learner ACCESS participation rate
  - All ELs complete the State's annual ELP assessment
    - ESEA Section 1111(b)(2)(G)(i)
    - IDAPA Rule: 08.02.03.111.06
- Students with an IEP or 504 Plan who were not able to participate in one or more domains due to a disability require an appeal

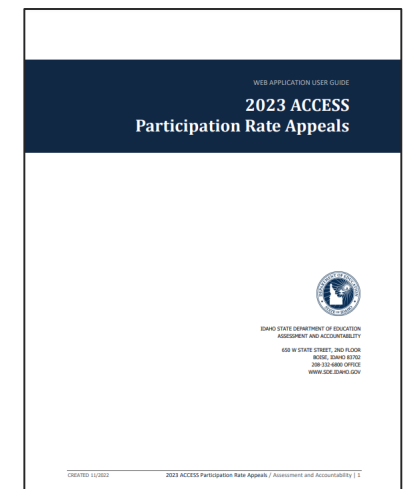


# ACCESS for ELLs Participation Rate Appeal

## Where to Submit an ACCESS Appeal



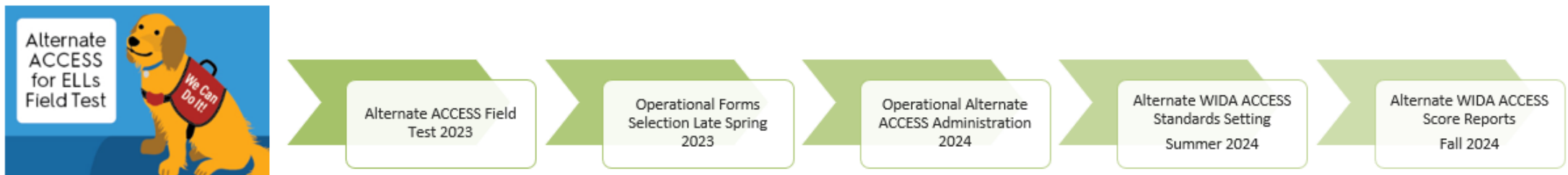
- ACCESS Appeals are submitted in the Idaho System for Educational Excellence (ISEE)
- Staff require permission to ACCESS Appeals web application to submit an appeal
  - District ISEE Coordinator can assign this permission set to district personnel
- 2023 ACCESS Participation Rate Appeals Web Application User Guide
  - Found within ACCESS Appeals web application under “Additional Resources”
  - Outlines process and how-to steps



# Alternate ACCESS for ELLs Field Test - 2023



- Idaho participated in the Alternate ACCESS for ELLs Field Test between February 14, 2023 and April 17, 2023
- New test name starting fall 2023
  - “WIDA Alternate ACCESS”
- **Delayed WIDA Alternate ACCESS results reporting**
  - WIDA Alternate ACCESS reports delayed until fall 2024 due to standards setting work in Summer 2024

# District Responsibilities



- IDAPA Rule: 08.02.03.111.05 - LEA requirement to communicate individual assessment results within **three weeks** of receiving scores
  - Provided in a language comprehensible to the parent
  - Provide reports that are accessible if a parent makes a request
  - ISRs available in 49 languages via the WIDA AMS
- Section 3115(a)(3) of ESEA - Evaluate the efficacy of the district's language assistance program(s) to ensure that ELs in each program acquire English proficiency

# District Responsibilities Program Evaluation



- “The U.S Department of Education's OCR oversees school districts broad discretion concerning how to ensure equal educational opportunity for ELLs
- The following guidelines have been outlined for school districts to ensure that their programs are serving ELLs effectively. Districts should:
  - identify students as potential ELLs;
  - **assess student's need for ELL services;**
  - **develop a program which, in the view of experts in the field, has a reasonable chance for success;**
  - ensure that necessary staff, curricular materials, and facilities are in place and used properly;
  - develop appropriate evaluation standards, including program exit criteria, for measuring the progress of students; and
  - **assess the success of the program and modify it where needed.”**

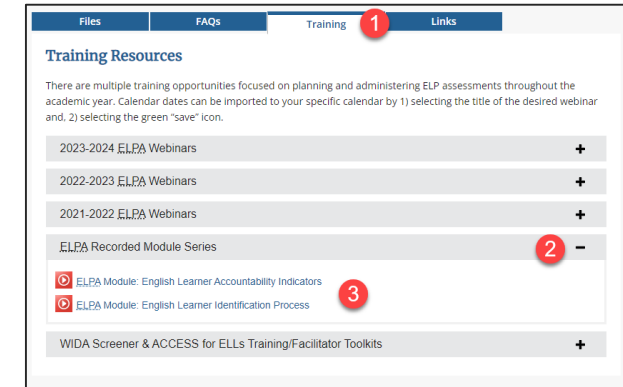
