**FINAL ORDER**

The Chief Certification Officer for the State of Idaho filed an Administrative Complaint against the teaching certificate issued to Amy Kathleen Carr, seeking for the Professional Standards Commission to impose discipline on Ms. Carr's certificate. See Idaho Code § 33-1209. Because Ms. Carr did not request a hearing within 30 days, and because Ms. Carr was determined to be in default by a hearing/presiding officer, the allegations in the Administrative Complaint are treated as admitted, Idaho Code § 33-1209(3), and are incorporated by reference as findings of fact.

Based on these findings, the Professional Standards Commission concludes that Ms. Carr willfully violated a principle of the Code of Ethics adopted by the State Board of Education. Idaho Code § 33-1208(1)(j). The Commission specifically holds that Ms. Carr willfully violated Principle II of the Code of Ethics that provides, "A professional educator maintains a professional relationship with all students, both inside and outside the physical and virtual classroom." Idaho Admin. Code r. 08.02.02.076.03.

Final Order – 1

Under Idaho Code § 33-1208, the Professional Standards Commission orders that the following discipline be imposed on Ms. Carr's certificate:

- Ms. Carr's Standard Elementary Certificate is **revoked**. She may not reapply for two years from the date of the final order.

This Order is effective on the day it is signed. This Order and the Administrative Complaint, which will be attached to this Order, are public records, and may be made available on the State Department of Education or the Commission's website.
