#### **NEW AGENDA ITEMS**

- <u>Assistance to States for the Education of Children with Disabilities</u>: from the Office of Special Education and Rehabilitative Services, Department of Education. Notice of proposed rulemaking.
  - "SUMMARY: The Secretary proposes to amend regulations under Part B of the Individuals with Disabilities Education Act (Part B of IDEA or the Act) that govern the Assistance to States for the Education of Children with Disabilities program, including the Preschool Grants program. Specifically, the Secretary proposes to amend the IDEA Part B regulations to remove the requirement for public agencies to obtain parental consent prior to accessing for the first time a child's public benefits or insurance (e.g., Medicaid, Children's Health Insurance Program (CHIP)) to provide or pay for required IDEA Part B services. [emphasis added] As there are no comparable consent requirements prior to accessing public benefits for children without disabilities, the removal of this consent requirement would align public benefits consent requirements for children with disabilities to those for children without disabilities and ensure equal treatment of both groups of children."
  - This notice of proposed rulemaking does not affect Idaho Medicaid School-Based Services at this time. We will discuss this issue in more detail during the September 13, 2023 meeting.
- <u>Biden-Harris Administration Takes Action to Help Schools Deliver Critical Health Care Services to Millions of Students</u>: This announcement regarding proposed federal rules does not affect Idaho Medicaid School-Based Services at this time. We will discuss this issue in more detail during the September 13, 2023 meeting.
- Delivering Services in School-Based Settings: A Comprehensive Guide to Medicaid Services and
   <u>Administrative Claiming</u>: The three quotes from this CMS guidance document state its purpose. They
   also illustrate that this guidance does not affect Idaho Medicaid School-Based Services at this time. The
   Department of Health and Welfare will review this guidance document in depth. We will discuss this
   guidance document in more detail during the September 13, 2023 meeting.
  - "This guide seeks to provide direction to State Medicaid/CHIP agencies and LEAs to deliver SBS in a manner that allows LEAs to obtain all the payments for which they can qualify, to then increase access to covered services for enrolled students. This guide also offers possible financially sustainable solutions for State Medicaid/CHIP agencies and LEAs, while acknowledging that behavioral health (mental health and SUD) services, and other medical conditions can be complex and may also require community-based resources outside of schools for effective treatment" (p. 6).
  - "How a State Medicaid/CHIP agency decides to structure SBS billing can depend on the structure of a locality's school system and the capacity for schools to furnish and bill for services" (p. 5).
  - "While schools are the setting for and can be providers of Medicaid and CHIP-covered services, the State Medicaid/CHIP agency has the leading role in determining which services are covered by Medicaid and CHIP when furnished in or by schools and how school-based providers are



paid. These decisions may be made in consultation with LEAs and SEAs, but ultimately it is the State Medicaid/CHIP agency's responsibility to determine how Medicaid and CHIP-covered SBS is implemented in each State" (p. 6).
