Below is information regarding the State Department of Education's contracts over \$25,000 in Fiscal year 2022.

- In Fiscal Year 2022, the total value of contracts over \$25,000, awarded by my department with state General Fund, represent .89 percent of the total state General Fund Appropriation budget for K-12 education (excluding ISDB).
- All of the contracts awarded by my office in FY2021 that exceeded \$25,000, totaled \$28.5 million dollars. Of that 40 percent of is covered by federal funds, and those contracts have very specific requirements, which are often best served by sole sources that have the specific expertise.
- 16 contracts totaling \$6.88 million were issued to other state agencies including Idaho Colleges & Universities keeping the money in Idaho.
- Some contracts were appropriated to specific vendors, such as Imagine Learning by the Idaho Legislature through the appropriation process.
- 52 contracts totaling \$10.73 Million are with individuals who are identified through an application and review process and selected because of their experience and expertise, including but not limited to our K3 Reading Coaches, Science Coaches and program coordinators for the Idaho Lives suicide prevention program.
- Other contracts are in place to meet both state and federal requirements, such as the contracts for our statewide assessments.
- I hired a dedicated procurement officer when I took office, a role applauded by the legislature at that time. The procurement process we have implemented includes checks and balances and multiple levels of approval for the over 1,500 contracts that my staff creates every year. My procurement officer negotiates with vendors each year to reduce costs, resulting in tens of thousands of dollars in savings.
- My staff works closely with our vendors to add high-value programs and increase software licenses at no additional cost. Examples include Imagine Math, Learning Literacy, Imagine Reading, Imagine Espanol and the Create Idaho Adobe program.
